

AN ORDINANCE AMENDING SECTION 410.07, SCHEDULE VII, OF THE TRAFFIC CODE TO AMEND THE LIST OF STREETS DESIGNATED AS ONE-WAY STREETS IN THE CITY; AND DECLARING AN EMERGENCY.

WHEREAS, after discussions with stakeholder groups and a public hearing, the City administration has recommended that the current two-way traffic patterns on Village Way and Park Lane (between the intersections of Library St. and First St.) be changed to one-way traffic patterns in the City’s Downtown District; and

WHEREAS, in preparation for the traffic pattern change described in the recital above, the City administration discovered that certain existing one-way streets within the City were never formally designated as one-way streets and, therefore, the City administration recommends that for the purposes of consistency and clarity within the Hudson Codified Ordinances the following streets be formally identified within the Hudson Codified Ordinances as one-way traffic patterns in the City:

- E. Main Street (one-way south) from Division St. to E. Streetsboro Street (SR 303);
- E. Main Street Extension (one-way south) from E. Streetsboro Street (SR 303) to dead end (approximately 150 ft. south of E. Streetsboro St. (SR 303)); and
- Church Street (one-way east) from N. Main St. (SR 91) to E. Main St; and

WHEREAS, this Council believes that the above referenced amendments to the Traffic Code as set forth in this Ordinance are in the best interests of the City and its residents.

NOW, THEREFORE, BE IT ORDAINED by the Council of Hudson, Summit County, State of Ohio, that:

Section 1. Section 410.07, Schedule VII, of the Traffic Code is hereby amended only as designated below:

“410.07 SCHEDULE VII – ONE-WAY STREETS.

Following are the one-way streets in the City:

Church St.	North Main St. (Route 91)	East Main St.	One-way east
E. Main St. Ext.	E. Streetsboro Street (Route 303)	Dead End (Approx. 150 feet south of E. Streetsboro Street (Route 303))	One-way to south
E. Main St.	Division St.	E. Streetsboro Street (Route 303)	One-way to south

Hudson Dr.	Darrow Rd.	Terex Rd.	One-way southwest
Hudson Dr.	S.R. 91	Terex Rd.	One-way southbound
Park Ln.	Library St.	First St.	One-way east
Village Way	First St.	Library St.	One-way west”

Section 2: Existing Section 410.07, Schedule VII, of the Traffic Code is hereby repealed.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Ordinance is an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents and motorists in the City and for the further reason the aforementioned traffic pattern modifications need to be immediately implemented in order to better serve the residents, visitors, and businesses in the City’s Downtown area; wherefore, this Ordinance shall take effect and be in force immediately upon its passage, provided it receives five (5) affirmative votes of members of Council, except that six (6) affirmative votes are required if all members are present; otherwise it shall be in full force and effect from and after the earliest period allowed by law.
