

PETITION FOR A SAFETY STUDY

GENERAL STATEMENT OF PURPOSE

THE CITY OF HUDSON ENGINEERING DEPARTMENT CONSIDERS ALL SAFETY RELATED ISSUES BROUGHT BEFORE THEM TO BE WORTHY OF INVESTIGATION IN ORDER TO PROMOTE A SAFE COMMUNITY AND NEIGHBORHOOD FOR OUR RESIDENTS.

SAFETY STUDIES REQUIRE AN INVESTMENT IN TIME AND MONEY TO SUCCESSFULLY ANALYZE THE REPORTED PROBLEMS.

THE BROAD INPUT GATHERED FROM A PETITION PROCESS WILL PROVIDE INFORMATION AND GENERATE A GENERAL CONSENSUS FROM RESIDENTS AND/OR MOTORISTS REGARDING THE REPORTED SAFETY PROBLEM.

THE PETITION GIVES THE ENGINEERING DEPARTMENT AND OTHER COOPERATING DEPARTMENTS (POLICE, FIRE, SERVICE) THE ABILITY TO SURVEY THE PROBLEM(S) AT HAND, RATHER THAN REACTING TO A SINGLE REPORT OR REQUEST.

PLEASE TAKE THE TIME TO REVIEW THE PETITION FORM ATTACHED AS WELL AS THE QUALIFYING CRITERIA TO BEGIN A STUDY BELOW.

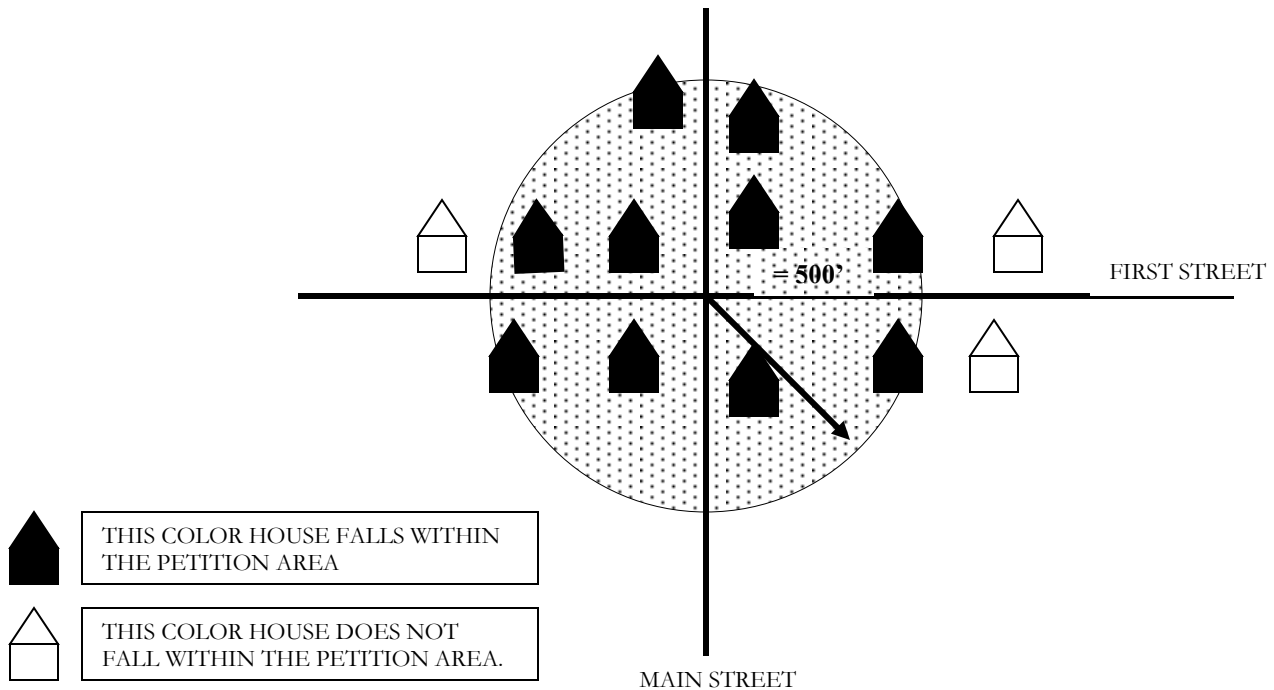

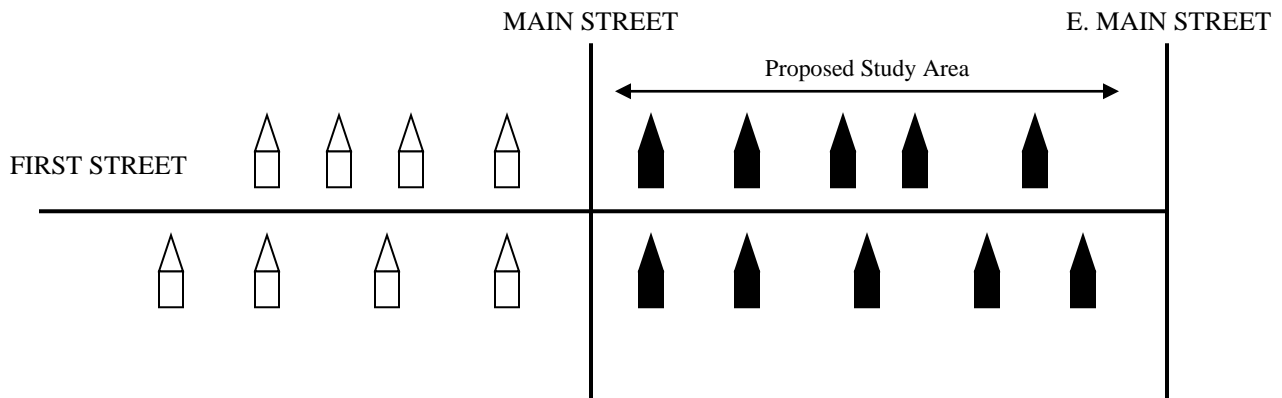

QUALIFYING CRITERIA TO BEGIN A STUDY

REQUESTING FOR A MULTI-WAY STOP SIGNAL AT AN INTERSECTION: The Petition must be filled out and signed by 50% of the total households living within a 500' (foot) radius of the proposed multi-way stop signal. Please see example below.



REQUEST FOR A SPEED STUDY ON A SPECIFIC ROADWAY: The Petition must be filled out and signed by 50% of the total households fronting the proposed roadway for study. Please see example below.



Example: The residents living on FIRST STREET between MAIN STREET and E. MAIN STREET want to have the speed limit lowered from 45 mph to 25 mph, therefore, 50% of the total households (5), would need to sign the petition and present it to the Engineering Department.
